BOND

Regardless of the language of Decedent's Will waiving bond, Petitioner must post a bond payable to the Knox County Chancery Court with a corporate surety before the Clerk will issue Limited Letters Testamentary. The amount of the bond must be equal to the total value of Decedent's Property. However, a bond is not required if (1) Petitioner is the sole beneficiary or (2) all adult heirs and beneficiaries consent in writing. A consent to waive bond form is available from the Probate Division.
