Contracts, injunctions, all torts, personal injury, property damage, malpractice, healthcare liability actions wrongful death, employment discrimination, civil rights, property disputes, special remedies and cases not otherwise specified.

\*Third Party Complaint - \$227.00

**Category Two Cases - \$264.50**

Appeals to the circuit court, writs of certiorari, transfers from foreign counties, worker's comp, and condemnations.

\*Third Party Complaint - \$152.00

**Category Three Cases - \$214.50**

Restoration of citizenship, name changes, minor settlements, foreign judgments and all other court approved settlements.

\*Third Party Complaint - \$102.00

**\*Category Three Adoptions - \$190.75**

\*Birth Certificate \$30.00 (Payable to Vital Records)

**Cross Filings/Counter Complaints - \$102.00**
